#### **Overview**

AIA Vitality members who have achieved Platinum Vitality Status can enjoy a S\$150 Platinum Bonus upon successful renewal of the AIA Vitality membership.

#### **Who may use this Benefit?**

AIA Vitality members who achieve Platinum Status are eligible for this bonus.

#### **How does the Benefit work?**

The Platinum Bonus is based on your AIA Vitality Status achieved as at membership anniversary date and will be paid via Direct Deposit.

Upon achieving Platinum Vitality Status, you will be receiving an email from AIA Vitality to provide us with your bank account details. Upon submission of your bank account details, your Platinum Bonus will be credited to you within 90 days after your membership anniversary date.

#### **Will I still be eligible for the previous Annual Cashback Benefit?**

Members whose next membership anniversary due date falls after 1 January 2019 and have achieved Platinum Vitality Status will be entitled to the Platinum Bonus amount at S\$150.

Members whose next membership anniversary due date falls between 1 January 2018 and 31 December 2018 will be entitled to the Annual Cashback amount as below.

## Annual Cashback

Bronze	\$0
Silver	\$0
Gold	\$60
Platinum	\$120

After 31 December 2018, this Annual Cashback Benefit will cease and be replaced with the Platinum Bonus.

- You must be an AIA Vitality member at the time of the Platinum Bonus/Annual Cashback payment to qualify for the Benefit.
- Please provide the bank details before your membership anniversary date. If the Direct Deposit is unsuccessful an email will be sent to the member requesting for an update of the bank details provided.
- Upon receipt of the valid bank account details, the Platinum Bonus/Annual Cashback will be credited into your bank account within 90 days following your membership anniversary date based on your AIA Vitality status as at your membership anniversary date.
